



INTERNAL RULES

In order for your stay to be as peaceful as possible, thank you for respecting some basic rules.

1. BOOKING

- a) Planning may be modified depending on weather conditions or technical issues out of our control. Thank you for understanding.
- b) Haul out for work : In case you need more time than expected to get the work done, and we need to move your boat to free the space for following boat's reservations, the handling costs invoiced will be 22 800 XPF TTC.
Our advice : it is better to book your storage for a bit longer than your original estimation.
- c) Long term storage : A deposit (nonrefundable) will be asked upon booking. Your booking will be confirmed only when the deposit is paid for.

2. WASTE DISPOSAL AND RECYCLING

- a) We subscribed Rave Mâ Label for recycling and this is a pay service. We invoice this service with a 5 000 XPF tax per boat for every haul out, this tax is mandatory.
- b) Plastic bottles for water and soda, aluminum cans, iron food cans, and glass are recycled. They have to be separated in 4 different categories, containers are located in the warehouse. Please ask at the office before throwing away so we can check recycling process is correct.
- c) Used motor oils have to be dropped off at the office. Rate for oil recycling is 250 XPF/ L.
- d) Same for used batteries, you need to bring it at the office as well. Rate is 50 XPF/Kg.

Before launching, please make sure to collect and sort your waste.

All waste left behind will be invoiced 15 000 xpf.

3. WATER

- a) Even here in Raiatea water is precious. Please make sure to turn off the tap when not in use. Install properly your hoses and fittings in order to avoid any leak.
- b) A special key is needed to open the tap. We ask for a cash deposit of 5 000 XPF to get this key, the deposit is given back when returning key to the office.

4. ELECTRICITY

- a) Maximum 16A. No A/C system or heavy battery loader on CNI plugs please.
Plug adapter is available at the office against a 20 000 XPF deposit (**Cash only**) that you get back when returning adapter.

5. WORKING ON BOATS

- a) Work on boats can be done by the owner and/or his crew. We have a team of workers allowed and insured for working along with CNI, please ask information at the office for skills you're looking for. No other worker than CNI approved ones is allowed to work on your boat when hosted by us.
- b) For any type of work that needs to call a different company or outsider, you have to ask the office : they need to be solicited by CNI directly.
- c) We rent scaffolding from the 2nd one you use. The first one is included.
Rate is 570 xpf TTC /day / scaffolding.
If our team is doing the work on your boat, rental price of scaffolding is included.
- d) For any messy job including fair amount of dust, it is mandatory to use a protective cover in order to respect other boats around. We rent protective covers for 342 XPF/ day / cover
Cover rental is included if our team is doing the job.
- e) Using spray painting systems is strictly forbidden. Only brushes and rollers are allowed.
- f) It is allowed to live on board for duration of work. The « life onboard » package will be invoiced according to your type of boat, please ask at the office to get the rates. This gives you access to water, electricity, waste disposal and facilities.
- g) Cutting and grinding work on steel boats is forbidden. We allow steel boats only for light sanding and classic painting works.
- h) We do not lend or rent tools, machines or equipment such as hoses or extension cables.

6. Assurance

- a) CNI is insured for boat handling. Your insurance needs to cover you when the boat is kept stationary on land.
